### COMPUTER NETWORK AND ACCESS AGREEMENT FOR STUDENTS

Through this Agreement, Alba Public School grants the student a Network User Account to be used only for the acceptable purposes listed in this document and the student agrees to follow the rules related to Network and Computer use as detailed in this document.

**By Signing this Agreement, the Student Acknowledges Understanding of and Agrees to the following:**

1. The student will be solely responsible for all use of the user account assigned to him or her. The sharing of passwords is prohibited. Students are responsible for any use of the account resulting from failure to protect passwords.
2. Alba Public School grants no privacy in the use of user accounts assigned to students. Alba staff have the ability to monitor and review the contents of students' network folders, web browsing history and any other computer activity done while using a school computer. Alba staff may review the aforesaid at their discretion.
3. **Acceptable** uses of Alba Public School Computers and Network resources by students include:
  - A. Using software provided by the district for completion of class work and other curricular goals.
  - B. Saving class work I files for the completion of assignments and other curricular goals.
  - C. Searching and browsing non-obscene Internet sites to aid the completion of assignments and other curricular goals.
4. **Unacceptable** uses of Alba Public School Computers and Network resources by students include:
  - A. Any violation of the policies detailed in the Student Handbook or of Federal, State, or Local Laws.
  - B. Attempting to install any software on Alba Public School computers.
  - C. Attempting to access Internet sites with obscene content, hate speech or any other material deemed by the Alba administration to be inappropriate for the educational environment.
  - D. Sending threatening, harassing or obscene communications.
  - E. Sending, receiving, storing or reproducing copyrighted materials without permission of the copyright holder.
  - F. Attempting to gain unauthorized access to and/or cause damage to computer systems inside of or outside of Alba Public School's Network.
5. Students violating the terms of this agreement will be subject to disciplinary action at the discretion of school personnel. Disciplinary action may include the partial and/or complete suspension and/or revocations of the student's computer access privileges and additional measures as outlined in the Student Handbook. This may impact the student's ability to complete program requirements.

6. Attempting to bypass the Technical Safeguards on Network Resources or Internet Access is considered a serious offense and is subject to disciplinary action. This includes, but is not limited to, attempts to obtain another User's password, attempts to bypass Internet content filtering, and attempts to access local Network Resources that are not designated for student use.
7. Violation and/or attempts to violate the law via District Computers, Network and/or Internet connection may be referred to Law Enforcement and are subject to disciplinary action as outlined in the Student Handbook.
8. Alba Public School reserves the right to block access to any Internet resource for any reason.
9. The User account granted through this agreement will remain valid only as long as the student remains enrolled in the Alba Public School District.
