IMPORTANT NOTICES

Alba Public School is required to make several public notices at the beginning of the school year. Please carefully review the next few pages of the newsletter to ensure you have all the information you need for a successful year.

STUDENT HANDBOOK NOTICE

At the beginning of each school year, Alba Public School distributes a student handbook to students in grades kindergarten through twelve. It is important for students and families to carefully review the handbook as it contains important updates on attendance, dress code, cell phone/electronics, discipline, and more.

Please note that graduation requirements for the class of 2016 and beyond are as follows:

- 4 credits of English
- 4 credits of Math
- 3 credits of Science
- 3 credits of Social Science
- 2 credits of World Language
- 1 credit of P.E./Health
- 1 credit of Art

Please note these other important policies:

- Students who leave school prior to 2:30 will be marked with a half-day absence.
- Dress code guidelines: all shirts must have sleeves and appropriate neckline.
- Video surveillance the Board of Education provides notice to all students, public, and employees of the potential use of video surveillance and electronic monitoring in order to protect district property, promote security, and protect the health, welfare, and safety of students, staff and visitors.
- Seniors: Each senior will have his/her picture taken for the class composite on the day of school-wide pictures; a tux for boys and drape for girls are mandatory and will be provided.

Parents are encouraged to review these handbooks and are expected to become familiar with the district policies and procedures relating to student conduct and academic programs. Parents are also encouraged to sign the acknowledgment form found in the back of the handbook and return it to school as soon as possible. Any questions relating to the handbook can be directed to the superintendent.


INSTRUCTIONAL MATERIALS

If you are interested in reviewing instructional materials used by the district, please follow this procedure:

- 1. Make the request to the principal of the building in which the instructional materials are used.
- 2. Submit completed form 9130F3 to the building principal.
- 3. Upon receipt of the form, the principal will schedule an appointment for you to visit the building to review and inspect the material indicated on the form.
- 4. Upon inspection and review, if you would like to file a complaint about the instructional materials, you should contact the Alba Public School superintendent at (231) 584-2000 for guidance on following the complaint procedures outlined in Alba Public School's policy.

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT

Directory Information Notice



Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with three directory information categories – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want Alba Public School to disclose directory information from your child's education records without your prior written consent, you must annually notify the District in writing. Please send this notification by *September 11, 2015* to: Office of the Superintendent, 5935 Elm Street, Alba, MI 49611. The District has designated the following information as directory information:

- 1. Student's name, address, and telephone listing
- 2. Date and place of birth
- 3. Major field of study
- 4. Participation in officially recognized activities/sports
- 5. Weight and height, if members of an athletic team
- 6. Dates of attendance
- 7. Date of graduation
- 8. Degrees, honors, and awards received
- 9. Honor rolls or scholarships received

MI IMMUNIZATION REQUIREMENTS + HEARING/VISION SCREENINGS

A child enrolling in public, private, parochial or denominational school in Michigan for the first time shall submit one of the following: 1.) statement signed by a physician that child has been tested for and immunized or protected against diseases specified by the director of public health, 2.) statement signed by parent/guardian that child has not been immunized because of religious convictions or other objections, 3.) request signed by parent/guardian that local health department gives the needed protective immunization. In addition, a statement that vision and hearing tests were passed is required unless parent indicates in writing that child cannot submit to the tests because of religious convictions.

Michigan law prohibits a principal or teacher from admitting new students without record of having at least one dose of each: measles, mumps, rubella, polio, diphtheria, tetanus and pertussis. Records for all entering kindergarten students and students enrolled from outside the district will be reviewed to ensure immunizations are up-to-date. Notice will be sent to parents/guardians if there is no immunization record upon school entry or if records are incomplete. Students not in compliance with immunization requirements will be excluded from school until documentation of immunization is presented. Michigan law requires that all students be immunized against the diseases listed in the chart below. Immunizations can be obtained from a physician or health department.

Communicable disease rules are the minimum standard for preventing disease outbreaks in school and child care settings. To best protect patients from all diseases we have the power to prevent, healthcare providers in Michigan should follow the 2015 Recommended Immunization Schedule at www.cdc.gov/vaccines or www.michigan.gov/immunize.

Effective Jan. 1, 2015, parents/guardians must obtain a certified non-medical waiver from a local health department.

SUBSTANCE ABUSE POLICY

Matters pertaining to Drug-Free Workplace/Drug-Free Schools and Communities Act Amendments of 1989.

Public Law 101-226 Alba Public School believes that use of illicit drugs and the unlawful possession of alcohol is wrong and harmful. Age- and developmentally-appropriate drug and alcohol education and prevention programs which address legal, social and health consequences of drug and alcohol use and provide effective techniques for resisting peer pressure.

1. Alba Public School prohibits unlawful possession, use or distribution of illicit drugs and alcohol on school premises or

- distribution of illicit drugs and alcohol on school premises or as part of any of its activities. *COMPLIANCE WITH THIS IS MANDATORY.*
- 2. Disciplinary action (consistent with local, state and federal

law) up to and including expulsion and referral for prosecution, will be imposed upon students who violate.

- 3. Discipline will be applied appropriately to the offense and offender following Alba Suspension and Expulsion Policy guidelines. Discipline may include a.) Completion of an appropriate rehabilitation program at parent/guardian expense, b.) Referral for prosecution. Parents are encouraged to seek family counseling agencies as necessary, with the associated costs borne by the parent.
- 4. Alba Public School will review its drug prevention program at least biannually to a.) determine program effectiveness and implement changes if needed, b.) ensure that disciplinary actions are enforced.

^{*}Current laboratory evidence of immunity is acceptable instead of immunization with antigen.

^{**}Students susceptible to these diseases may be excluded from school. All doses of vaccines must be given with appropriate spacing between doses and at appropriate ages to be considered valid

[†]Hepatitis B may be administered as early as birth.

RIGHT TO REQUEST QUALIFICATIONS

Because Alba Public School receives federal funds from Title I program, parents and guardians may request the following information about the professional qualifications of their child's classroom teacher(s):

- 1. Whether the teacher has met Michigan licensing requirements for the grade level(s) and subject area(s) for which the teacher provides instruction;
- 2. Whether the teacher is teaching under an emergency permit or other provisional status through which Michigan licensing requirements have been waived;
- 3. The teacher's college degree(s), major(s), and field(s) of discipline, as well as any graduate degree or certification.

This information may also be requested about any paraprofessional who provides Title I services to your child. To receive this information, contact Alba Public School superintendent at 5935 Elm Street, Alba, MI 49611. Requests will be processed in a timely manner.

PRIVACY NOTICE CONSENT

The Protection of Pupil Rights Amendment (PPRA), 20 USC § 1232h, requires Alba Public School to obtain consent from a parent or allow a parent to opt out of his/her child's participating in certain school activities, including student survey, analysis, or evaluation in an applicable program that concerns one or more of the following eight areas ("protected information surveys"):

- 1. Political affiliations or beliefs of the student or student's parent;
- 2. Mental or psychological problems of the student or student's family;
- 3. Sex behavior or attitudes;
- 4. Illegal, anti-social, self-incriminating, or demeaning behavior;
- 5. Critical appraisals of others with whom respondents have close family relationships;
- 6. Legally recognized privileged relationships, such as with lawyers, physicians, or ministers;
- 7. Religious practices, affiliations, or beliefs of the student or parent/guardian;
- 8. Income, other than as required by law to determine program eligibility or financial assistance.

This opt-out right also applies to the collection, disclosure, or use of student information for marketing purposes ("marketing surveys") and to certain physical exams and screenings.

PEST MANAGEMENT ADVISORY

Alba Public School uses an Integrated Pest Management (IPM) system to control pests. IPM uses all suitable techniques with the intent of preventing pests from reaching unacceptable levels or to reduce an existing population to an acceptable level. Pest management techniques emphasize pest exclusion and biological controls. However, as with most pest control programs, chemical control may be used.

You have the right to be informed prior to any pesticide application made to the school grounds or buildings. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students. You will be notified following any such application. If you need prior notification, please notify your school building principal(s) *in writing* annually.

STUDENT RECORDS

Student records, other than directory information, shall be available only to students and their parents, eligible students, and designated school personnel who have a legitimate educational interest in the information, or to other individuals or organizations as permitted by law. The term "parents" includes legal guardians or other persons standing in loco parentis (such as a grandparent or step parent with whom the child lives, or a person who is legally responsible for the welfare of the child). The term "eligible student" refers to a student who is eighteen (18) years of age or older, or a student of any age who is enrolled in a postsecondary institution.

"Legitimate educational interest" shall be defined as a "direct or delegated responsibility for helping the student achieve one or more of the educational goals of the District," or an administrative, supervisory or instructional task, or a service or benefit for the student or the student's family.

To request this information or amend a child's educational records, please contact the principal of the building the child attends or most recently attended. The District will comply with a legitimate request for access to a student's records within a reasonable period of time. Based upon reasonable requests, viewers of educational records will receive explanation and interpretation of the records.

Only "directory information" regarding a student shall be released to any person or party other than the student or his/her parent without the written consent of the parent; or if the student is an eligible student, the written consent of the student, except those persons or parties stipulated by the District's policy and administrative guidelines and/or those specified in the law. If you believe that your rights have been violated under Federal Law (FERPA and the Protection of Pupil Rights Amendment), please contact the superintendent at 5935 Elm Street, Alba, MI 49611.

COMPLAINT PROCEDURE

Any person who believes that s/he has been discriminated against or denied equal opportunity or access to programs or services may file a complaint, which shall be referred to as a grievance, with the District's Civil Rights Coordinator, Superintendent, Alba Public School, 5935 Elm Street, Alba, MI 49611, (231) 584-2000. The individual may also, at any time, contact the U.S. Department of Education, Office of Civil Rights, 600 Superior Avenue, Room 750, Cleveland, Ohio 44114-2611.
